

With a view to provide opportunity for continuance of research contributions by talented Science and Technology teachers in Universities who are nearing superannuation or have superannuated and continue to actively associate with guiding Ph.D candidates and have not completed 68 years of age in State Universities/Central Universities, the UGC has evolved the "**UGC – BSR Faculty Fellowship Scheme**" with the following **Objectives:**

- (i) To facilitate talented teachers in Science and Technology at the verge of superannuation and to continue their productive research for an additional period of THREE YEARS after superannuation.
- (ii) To play a role of Research Mentorship for young researchers and Ph.D students.

I am, by direction, to inform you that you have been selected after due evaluation process by the **MHRD/UGC-Empowered Committee** for the award of **UGC-BSR FACULTY FELLOWSHIP**. This Award carries the following:

- (i) The UGC-BFF Award will carry a fellowship amount of Rs. 46,500/- per month (consolidated) for a maximum duration of THREE YEARS, which would be exclusive of the pension and other retirement benefits to the teacher from the parent university.
- (ii) A Consumable/Contingency/ Travel grant of Rs. 3.0 lakhs per annum.

This has reference to your proposal submitted online for the year 2016-17 for award of BSR Faculty Fellowship, I am pleased to inform you that on the recommendations of the BSR-Empowered Committee; the University Grants Commission has agreed to offer you BSR Faculty Fellowship. The Fellowship would be available from the actual date of joining up to the age of 68 years or upto three years (non-extendable) of the award whichever is earlier. The detail of the amount of Fellowship/Contingency is given in Annexure-I. The latest date for joining the award is the date of superannuation from your current position. The guidelines of the scheme are available on the UGC website: [http://www.ugc.ac.in/pdfnews/1621072\\_BSR-Faculty-Fellowship-new.pdf](http://www.ugc.ac.in/pdfnews/1621072_BSR-Faculty-Fellowship-new.pdf).

It may be noted that the Fellowship amount shall be disbursed through Canara Bank to the bank account of the awardee, (any Bank) directly. The UGC has developed a dedicated webportal (<https://scholarship.canarabank.in/AdminLogin.aspx>) for capturing data of the fellows under different fellowship / scholarship schemes. The Universities/Colleges/Institutions will submit the master data of the eligible beneficiaries on the portal with a unique users profile (user name and password). The bank account numbers of the beneficiaries will be validated through PFMS for creation of beneficiary ID.

The Universities / Institutions / Colleges shall update the information in the master data (regarding continuation, HRA, up-gradation, resignation etc.) of the beneficiaries quarterly. Based on the master data received from the concerned Universities/Institutions/Colleges the payment of the fellowship will be made to the beneficiaries directly into their account.




It may be noted that UGC has proposed to link "AADHAAR" with awardee's bank accounts number so that there can be direct cash transfer and effective disbursement of fellowship into the bank account of the awardee. In this regard Secretary, UGC has already requested to Universities for helping the awardees for Aadhaar Enrolment vide his D.O. letter No.F.14-34/2011(CPP-I) dated 11.01.2013.

Please note that the award is liable to be cancelled and it will also attract legal action against the awardee in the following cases:

- i) If the awardee is found to be ineligible to receive the award, at any point of time during the entire duration of the fellowship.
- ii) Misconduct of Awardee.
- iii) Unsatisfactory progress of research work of the awardee.
- iv) Any other fellowship is drawn from other source(s).
- v) Concealment of facts and on any other ground of misconduct.


