## ADMINISTRATIVE ORDER

Subject: Network Project entitled "Marine Coastal Ecology of West Coast of India" of M.K. Bhavnagar University(MKBU) under Research & Development in Earth and Atmospheric Sciences.

Sanction of the President is hereby conveyed under Rule 18 of the Delegation of Financial Power Rules, 1978 for implementation of the project for Network Project entitled "Marine Coastal Ecology of West Coast of India " of Maharaja Krishnakumar Sinhji, Bhavnagar University(MKBU), Bhavnagar, at an estimated cost of Rs. 3,74,77,535/- (Rupees three crore seventy four lakh seventy seven thoucand five hundred and thirty five only) during the three years period (Rs. 1,64,88,274/during 1<sup>st</sup> Year, Rs. 1,07,28,761/- 2<sup>nd</sup> Year and Rs. 1,02,60,500/- during 3<sup>rd</sup> Year) as per details given below.

2.0 Objectives: The main objectives of this project is R&D in marine biodiversity/coastal ecology and marine pollution, covering the following aspects.

- Diversity and Ecology of Lichens, Corals and macrofauna as Crabs and Anthozoans.
- Culture dependent and independent diversity of purple phototrophic bacteria, biofilm producing bacteria, actinomycetes and bacterial diversity associated with metallic pollutants.
- Impact of industrial pollution on coastal and marine ecosystem of Gulf of Kachchh and South Gujarat, biodegradation of pollutants with special reference to poly aromatic hydrocarbons (PAHs) and its bioremediation.

#### 3.0 Programs:-

Gujarat having the longest coastline of 1653 Km, constituting 22% of the Country's total coastline has largely remained unexplored in terms of coastal and marine Biodiversity and impacts of natural and anthropogenic perturbations on the critical coastal habitats/ecosystem. The economy of Gujarat to a significant level is linked to coastal region and depends on coastal resources. As a result, most parts of these coastal regions face pressures from different driving forces of economic development, urbanization, industrialization, etc. These independently and collectively cause many serious environmental problems in the coastal and marine environment. High benefits come with equally high risks of ecological deterioration through over-exploitation of the marine resources and habitat destruction.

The network project will focus for R&D on two components namely, (i) PC1: Marine Biodiversity, and (ii) PC2: Marine Pollution. Total 12 proposals under two components (PC1: 9 and PC2: 3) have been submitted by different organizations under both the components and for Earth Science & Technology Cell (ESTC) MKBU for operational responsibilities the third component (PC3).
