Ordinances and Regulations

<u>O.D.E.I.L.</u>1. Candidate shall be admitted to the course should have passed a bachelor's degree examination having three years duration from this university or any other recognized university.

O.D.E.I.L.2. The Diploma Course is a regular full time of one year duration consisting of two academic terms.

O.D.E.I.L.3. The admitted candidate can not join any other course of study without prior permission of the university.

The word college/institution included college building, sports complex, Hostels and such other components which are within the purview of the college. In case of occurrence of any such incident the violator shall be dealt with very seriously and appropriate stringent action be taken by the principal of the college observing principle of natural justice.
